**1. Identification of the controller and of data categories**

**3. Processors**

- d. The applications of the Etouches management services company.
- e. Partners of the conference or event that is organised by the Controller.
- f. Alternatively, other providers of processing software, services and applications; more fully described in the Privacy Policy (Principles of Personal Data Processing).
